- Growing influence of WPS agenda in furthering women's rights and security in conflict / post-conflict societies.
- Lack of reference to reproductive rights.
- Why is this? Why is it important?
- Methods content analysis of all Resolutions and National Action Plans of individual states.

Why reproductive rights?

- Reframing the concept of security lack of access to legal, safe abortion results in insecurity for women.
- Accessing full citizenship and participation (Lister, 2003).
- Measuring commitments to gender equality in conflict transformation `a crude but effective measure' (Ni Aolain et al, 2011).
- Challenging conservative, essentialised visions of women going beyond protection to rights (Shepherd, 2008).
