# Where do you start (1)?

- Research your funder and sign up for funding alerts

- Read and research your funder website including:
  - **READ THOROUGHLY** the funding call (or guidance)
  - Find out what projects have been funded before?
  - Understand what is it the funder wants?
  - **SCRUTINISE** the submission instructions (e.g. attachments, supporting letters, using a funder portal, etc.)

# Where do you start (2)?

- Talk with experienced research grant holders in your HEIs and with staff who are involved with and work with the funders (e.g. reviewers and panellists)
- **Don't be afraid to have a conversation with the Funder**
- Contact your institutional Research Support Office (RSO) for help
  - RSO will be able to offer lots of support and guidance including
    - How to plan and prepare your application
    - Costing your budget
    - Institutional approvals and supporting letters/statements
    - and much more e.g. ResearchCONNECT

# Where do you start (3)?

- Talk to your Head of Department
- They will be able to offer you help and support, particularly with:
  - departmental processes (workload monitoring, approvals, etc.)
  - mentoring arrangements
  - peer review processes
- Talk to your networks
- Talk to potential stakeholders, supporters, and users of the research
- **Situate the context from which you are working (academic and societal)\* see CfS in sample application provided**
- **Think about the impact you want to make and what's possible?**

# Useful Tips



- Start the bid writing process as soon as you can....
- Read the **funder guidance/call document** and notify your **Research Support Office** – do your research topic and activities address the requirements of the call?
- Look at **previous successful grant applications** to see what has been funded.
- Prepare your **budget** in advance of your submission – and ensure the approval process is completed.
- Make sure your application is **peer-reviewed**: allow your peer reviewer(s) time to read your application and feedback in good time (discuss with Head of Department).
